CONDITIONS OF MEMBERSHIP

- Memberships are not transferable.
- All applications for membership are subject to approval by the club which shall have sole discretion to approve or reject same for any reason whatsoever.
- Membership conditions require a minimum of one year commitment from the date this agreement is signed.
- 4. Early termination shall result in a "Early Termination Fee of \$150 or the remainder of dues under this agreement.
- 5. The Club reserves the right to increase fees at any time upon the giving of thirty days notice to the members. Members in good standing will not have fees increased during the initial 12 months of the membership agreement.
- 6. The Club shall be entitled to immediately terminate a membership by written notice upon any of the following occurrences: abuse of or destruction to the Club's property or their premises; abuse of other members or Club employees; or theft of any property belonging to the Club or a member or visitor.
- Family Memberships include the primary member, spouse and children under the age of 18 (22 if enrolled in college.)
- 8. THIRTY DAYS WRITTEN NOTICE IS REQUIRED TO CANCEL OR TERMINATE A MEMBERSHIP. Such termination of membership DOES NOT release individual from liability for any unpaid dues, charges, or fees through the month of termination. A membership termination is not retroactive and terminating members are not entitled to a refund of any part of the Membership fees or dues.
